I) Call meeting to Order/ Welcome and Updates - Priya

- President/Vice-President updates:
 - Quick update on the election to board:
 - Congratulations on an election well run, we had some learnings like improve validation to avoid students for roles, further clarify if current board can vote or not
 - Welcome to New PFSO team members for 2024-2025
 - Trinh Tran Fundraising chair (no contest as sole candidate)
 - Linda Lu & Bhavesh Parmar Co-secretaries for year
 - Amee Johal Class of 2028 lead

II) New business

- DPIE updates Gary Leach:
 - Fireworks booth This is one of the biggest profit makers in a short time towards fund-raising. DPIE partners with rotary & schools to offer up spots at fireworks booth(Schools with biggest participation

got upto7k). A sign-up (signupgenuius) has been set-up. There are a total of 176 slots. For EHS – goal of 17 slots to be signed up by the end of this month. Are we limited to only 17? No! We can go for more – 25-30. Fundraising directly proportional to number of slots signed up for by school.

- O DPIE Connects This is a program about connecting working professionals with high-schools for career focused discussions. In May there are 4 speakers coming in one from Lawrence Livermore National Laboratory, one from a banking profession, board-member of a tech-start-up to speak with students during a lunch period and give them a perspective of their roles and what opportunities their area offers. For the next year looking to pick a day of the week to have professionals come in at lunch break. If there are more volunteers connect them with Gary. The expected time commitment is for about 45 minutes for one session.
- High School summer program there are 6 programs for high-school Advanced Algebra-II, Arts, Biology, Honors Chemistry, Pre-calculus, PE. So far about 107 students have signed up, there is space for 100 more. There are other programs like learning guitar which are also available for summer.
- Priya recommended connecting with Academic Chair (Bharat) & Club chair (Veena) to help take these suggestions forward for the upcoming year.
- Proposal to start EHS Robotics team Jagadish Vasishta
 - Introduction Jagadish is in the mechanical engineering industry and is an engineering manager at Northrop Grumman. In addition to professional responsibilities he has been mentoring students for robotics competitions and involved in children's causes over 12 years.

Motivation:

- Got to know that there is no robotics team yet at EHS
- As part of non-profit Rise volunteering, have taken teams to FIRST(For Inspiration and Recognition of Science and Technology) world championships – this is by mentoring the team through their elementary/middle years, and in-line with interest to continue volunteering in this space.
- As a mechanical engineer provide perspective into what goes into building products from the non-software aspect, generate and inspire STEM, help kids help others.

Outline of proposal

- Develop problem-solving skills, leadership & presentation skills preparing kids for future, develop business plan, engineering portfolio, build a robot from scratch, design, fabricate, CAD, 3-d printers, work with others to engage to build the robots.
- Funds ~15k, comes from fundraising companies, donations from individuals
- Team structure if we start a team, need help with mentors, if we can get enough support we can form couple of teams, there are several competitions in the Bay-area ex: Norcal FTC championship that teams can look to participate.
- Constraints \$\$ + workspace current workspace is out of garage, will need space for equipment. Will need budget for registration, transportation for competitions.
- Age range FTC middle schoolers to high-schoolers Do the kids need to pay to participate?
 This was needed in the current year. For future if there is contribution/support from PFSO, student contribution will be lower, but will likely need student contribution going forward also.

Next steps - Connect with Veena (Club chair) to gauge interest from students for this club.

 - o Funds from all ticket sales will go to PFSO, vendors will be charged 20%
 - o Prior to the event, decided not to charge the outside vendors
 - o Did not draw a distinction between student vendors & outside vendors.
 - o Total funds Gardeners of the galaxy 71\$ Ryan 136\$
 - o Curry kona Nihal 146\$ 50% of the profit will be donated to ASB, as Nihal is on leadership
 - o Total PFSO funds 2001\$
 - o Raised by clubs through purchases 34\$
 - 2441.02\$ raised by clubs, Veena net sales removing square fees 4829 per Shweta 4863 gross sales of donation, Difference 34.21\$
 - All EHS clubs have faced fundraising challenges and will appreciate seed money recommendation 1) is student led vendors keep 100% of their profits 2) PFSO distribute upto a max of 75\$ to the participating clubs remaining funds can be used to cover custodial/janitorial charges/cover square fees. 3) Treasures to verify the proposed events and see that this is a net-0 for PFSO. 4) Close the square site set-up for fun-run. 5) Provide each club money from ticket sales upto 75\$, charging all non-student vendors 10% if ticket sales are < 100 and 20% if ticket sales > 100, student-led vendors keep 100% of funds for their own non-profit-organizations.
