(1 year commitment- 1 Position available)

Co-Secretary/Director of Communications: Maintain the PFSO website, writing and submitting weekly newsletters, perform social media updates and other communication related activities.
(1 year commitment - 2 Positions available)

Director of Community Outreach: Work with the board to plan, develop, and coordinate a strong schedule of creative and productive fundraising activities to fund the operating budgets of the PFSO. Work closely with members, donors, EHS faculty, and communities.
(1 year commitment - 1 Position available)

Class of 2028 Reps: Be the liaison between students and the PFSO. Coordinate volunteers for student activities. Work in conjunction with class faculty advisors. Supervise student activities and fundraisers.
(2 year commitment - 2 Positions available)
